### Governance points to note:

- Responsible for adopting new policy, codes of conduct and rules that affect club organisation.
- Officers' positions are honorary; no remuneration either in cash, cash equivalent or BIK.
- Officers are automatically the only members of the Committee.
- Officers will be elected every 2 years (such period commencing from the date the Club is established as an Unincorporated Association and opens its first bank account) at the Annual General Meeting.
- Only Officers have the right to vote at meetings of the Committee; Chair has 1% casting vote.
- Meetings convened by Secretary/Chair and held no less than 4 per year (i.e., quarterly).






# **Overview of Membership and Events 2024/25:**


Membership Sec



- At the end of 2023-24 the Club had 211 subscribed members
- 156 renewed the majority doing so within the first two months of the 2024-25 membership year
- $\circ~$  As at 26 March, across the year 62 new members had subscribed
- Lower numbers of new subscriptions in June, July and October to December. Higher numbers in April, May, August, September and January to March.
- As at 26 March, subscriptions stand at 218 (the budget was based on 190)
- Membership fees £3,925 actual vs £3,665 budgeted = £260 budget beat



Membership Sec




- In 2024-25 we had 50 Sunday sessions, the only closures being on Turks Head 10 and Cabbage Patch 10 days
- Figures are approximate average for each month (we didn't record figures in 8 of the 50 weeks)
- Overall average attendance in 2024-25 is very close to the average of the previous year (approximately 50)
- Most significant differences were lower figures in November and January in the current membership year compared with 2023-24 (January 2025 was affected by some significantly challenging weather conditions)
- Massive thanks to our team of leaders and organizers that make this sustained consolidation possible and enable us to work towards the standard of inclusiveness to which we aspire

# Sunday Sessions 2024/25






Membership Sec



- Wednesday Bearcats started in July 2023
- In 2024-25 we had 23 Wednesday sessions (only one run in January due to Bank Holiday and Stadium event).
- Attendance is notably higher in spring/summer due to daylight conditions. April to September, we usually have 3 or 4 different pace groups. October to March, we usually have 2 different pace groups.

### BRC proposed 2025/26 Fees:

Timeframe	Cost	Comment
1 Apr – 30 Jun	£20.00	Full membership (*See note below about renewals)
1 Jul – 30 Sep	£15.00	£5 reduction
1 Oct - 31 Dec	£10.00	£10 reduction
1 Jan – 28 Feb	£5.00	£15 reduction; in March no charge until following year

### Governance points to note:

- Membership fees will coincide with the financial year.
- All membership fees will come due for payment on the 15th day after the end of the previous financial year (which runs to 31 March of each year).
- Fees will be reviewed on an annual basis by the Committee and will take into account all current and anticipated running costs of the Club for the forthcoming financial year.
- Fees may also be reviewed in exceptional circumstances.
- Changes to fees are to be approved by the Members at an AGM or EGM of the Club.

\* **For 2025-26 only,** members who **paid a subscription in 2024-25** and renew before 30 April 2025 will qualify for a **reduced 2025-26 subscription of £10**


